



Terms and conditions

Participation in this grocery grab is deemed the entrance acceptance of these terms and conditions of entry. Acceptance of these terms and conditions is a condition of entry into this Competition.

Raffles, lotteries, and games of chance - these gambling activities are covered by the Gambling Act 2003 and ours is classified as Class 2. As such our draws will be supervised by an appropriate person (lottery game rule 6 bracket (14)).

- 1. This competition is managed by New World Kapiti 159 Kapiti Rd, Paraparaumu. Kapiti Coast. 5032 and Paraparaumu Beach School PTA.
- 2. 1st Prize grocery grab 120 seconds grocery grab 2nd Prize grocery grab 90 seconds grocery grab 3rd Prize grocery grab 60 seconds grocery grab
- 3. The grocery grab will be completed at New World Kapiti on Friday 29th of November 2024 at 7.30am
- 4. The grocery grab winners will meet the owners of New World Kapiti and the representing PTA members at the entrance to New World for a briefing prior to the grocery grab that morning.
- 5. The fundraiser and sale of tickets will start Monday 14th of October 2024 and end Friday 22nd of November 2024. Each ticket is \$5 to purchase.
- 6. Multiple entries are permitted.
- 7. The promoter shall not bear any responsibility to notify participants of incomplete entries.
- 8. The promoter's decision in relation to the selection of prize winners is final; no correspondence will be entered into regarding the outcome of this competition.
- 9. The prizes are strictly non-transferable, products collected during the grocery grab cannot be redeemed for a cash or credit equivalent. New World Kapiti usual returns policy will not apply.
- 10. The prize draw will take place Monday the 25th of November 2024, Paraparaumu Beach School Principal Jess Ward and a representative from the New Zealand Police will be present to witness the drawer.
- 11. Winners will be announced publicly on Monday the 25th of November 2024 on the New World Kapiti Facebook page and the Paraparaumu Beach School Facebook page, the winners will be notified by a phone.
- 12. If any of the prize winners are unable to make the date, time or location as outlined, the prize will automatically be forfeited without compensation to another contestant, the prize will be transferred to the next name drawn.
- 13. The contestant will be alerted after each 30 second interval has elapsed.
- 14. Each prize winner may nominate a representative to push the trolley while they pick the groceries.
- 15. If using a nominated representative, the nominee can only push the trolley e.g., Trolley pusher cannot assist the grabber. Both pusher and grabber must stay together for the duration of the grocery grab.
- 16. Any items that are broken or damaged by the contestants during the trolley dash will not be substituted for undamaged items.
- 17. Contestants are encouraged to have family/friends present to watch the trolley dash, but they must watch from behind the tills so as not to impede the trolley dash.

- 18. There will be a New World staff member in close approximation to time, film and oversee the grocery grab.
- 19. The start line will be at the front entrance of New World Kapiti, inside of the "sharks' teeth" in the produce department.
- 20. Items must be individually picked and CANNOT be strong armed e.g., the grabber CANNOT load their arms with goods.
- 21. A maximum limit of four of any of the same sort of product e.g., maximum of four meat and or poultry items, four lolly items, four chocolate items etc. applies.
- 22. Alcohol, Lotto, instant Kiwi, tobacco, and gift voucher products are excluded regardless of the age of the winner.
- 23. Extra trolleys will be placed at the start line for the grabber to use if required, but not necessary. If using an additional trolley, the first trolley must be returned to the start line to swap for an empty trolley.
- 24. In the event of any dispute regarding the rules of conduct or the results of this competition the decision of the promoter will be final.
- 25. The promoter reserves the right to refuse a prize to any participant or disqualify a participant who breaches any of these terms and conditions or who acts in such a manner that in the promoter's sole opinion, tends to bring the promoter or its brand into disrepute.
- 26. The maximum number of tickets sold for the event will not exceed 2500 thousand tickets.
- 27. Video footage of the grocery grab will be used for promotional material including social media, New World Kapiti Facebook page, Paraparaumu Beach School website and Facebook page, the winner and anyone assisting the winner must agree to be filmed and have their images used on social media.
- 28. The participant and trolley pusher (if one is nominated) will be required to wear flat CLOSED TOE shoes and be physically able to participate in the event.
- 29. The promoter does not accept any responsibility for any loss, injury or damage whatsoever suffered by any participant as a result of their taking part in the grocery grab. The promoter shall not be liable for any recourse or claims as a result of any kind of physical, mental or other loss or damage suffered due to the participants involvement in the grocery grab.
- 30. The contents of the trolley/s will be checked after the grocery grab is complete if there are any disallowed items, these will be forfeited and returned to New World.
- 31. The contents of the trolley will be scanned at the till to ascertain the total value of the goods collected during the grocery grab.
- 32. In the event of COVID-19 or an alert level change, the draw will proceed but redeeming of prizes may be held at a later date if required due to government guidelines. If the winner tests positive and has to isolate, they can nominate another person to do the grab in their place.
- 33. 100% of all proceeds will go to Paraparaumu Beach School.
